- CCPA: Collection of personal information about minors
   We do not knowingly collect personal information of consumers
   who are below the age of 16.
- California's "Online Eraser" law, part of California's Business and Professions Code Sections 22580-22582, requires operators of certain websites and online services targeting minors to allow registered Users who are under the age of 18 and residents of California to request removal of content they post. If a registered User fits that description and posted content on Almina Online Kids Academy Language Learning Platform, they may request removal of such content by contacting the Owner or its privacy policy coordinator at the contact details provided in this document.

# **Types of Data collected**

Among the types of Personal Data that Almina Edutech - Almina Online Kids Academy collects, by itself or through third parties, there are: Tracker; Usage Data; first name; email address; last name; Data communicated while using the service; payment data; country; phone number; Approximate location permission (non-continuous); Microphone permission; unique device identifiers for advertising (Google Advertiser ID or IDFA, for example); various types of Data; User ID.

Complete details on each type of Personal Data collected are provided in the dedicated sections of this privacy policy or by specific explanation texts displayed prior to the Data collection.

Personal Data may be freely provided by the User, or, in case of Usage Data, collected automatically when using Almina Online Kids Academy Language Learning Platform.

Unless specified otherwise, all Data requested by Almina Edutech - Almina Online Kids Academy is mandatory and failure to provide this Data may make it impossible for Almina Edutech - Almina Online Kids Academy to provide its services. In cases where Almina Edutech - Almina Online Kids Academy specifically states that some Data is not mandatory, Users are free not to communicate this Data without consequences to the availability or the functioning of the Service.

Users who are uncertain about which Personal Data is mandatory are welcome to contact the Owner. Any use of Cookies – or of other tracking tools – by Almina Edutech - Almina Online Kids Academy or by the owners of third-party services used by Almina Online Kids Academy Language Learning Platform serves the purpose of providing the Service required by the User, in addition to any other purposes described in the present document and in the Cookie Policy, if available.

Users are responsible for any third-party Personal Data obtained, published or shared through Almina Online Kids Academy Language Learning Platform and confirm that they have the third party's consent to provide the Data to the Owner.

# Mode and place of processing the Data

## Methods of processing

The Owner takes appropriate security measures to prevent unauthorized access, disclosure, modification, or unauthorized destruction of the Data.

The Data processing is carried out using computers and/or IT enabled tools, following organizational procedures and modes strictly related to the purposes indicated. In addition to the Owner, in some cases, the Data may be accessible to certain types of persons in charge, involved with the operation of Almina Edutech - Almina Online Kids Academy (administration, sales, marketing, legal, system administration) or external parties (such as third-party technical service providers, mail carriers, hosting providers, IT companies, communications agencies) appointed, if necessary, as Data Processors by the Owner. The updated list of these parties may be requested from the Owner at any time.

# Legal basis of processing

The Owner may process Personal Data relating to Users if one of the following applies:

- Users have given their consent for one or more specific purposes. Note:
   Under some legislations the Owner may be allowed to process Personal
   Data until the User objects to such processing ("opt-out"), without
   having to rely on consent or any other of the following legal bases. This,
   however, does not apply, whenever the processing of Personal Data is
   subject to European data protection law.
- provision of Data is necessary for the performance of an agreement with the User and/or for any pre-contractual obligations thereof;
- processing is necessary for compliance with a legal obligation to which the Owner is subject;
- processing is related to a task that is carried out in the public interest or in the exercise of official authority vested in the Owner;
- processing is necessary for the purposes of the legitimate interests pursued by the Owner or by a third party.

In any case, the Owner will gladly help to clarify the specific legal basis that applies to the processing, and in particular whether the provision of Personal Data is a statutory or contractual requirement, or a requirement necessary to enter into a contract.

### **Place**

The Data is processed at the Owner's operating offices and in any other places where the parties involved in the processing are located.

Depending on the User's location, data transfers may involve transferring the User's Data to a country other than their own. To find out more about the place of processing of such transferred Data, Users can check the section containing details about the processing of Personal Data.

Users are also entitled to learn about the legal basis of Data transfers to a country outside the European Union or to any international organization governed by public international law or set up by two or more countries, such as the UN, and about the security measures taken by the Owner to safeguard their Data.

### **Retention time**

Personal Data shall be processed and stored for as long as required by the purpose they have been collected for.

Therefore:

- Personal Data collected for purposes related to the performance of a contract between the Owner and the User shall be retained until such contract has been fully performed.
- Personal Data collected for the purposes of the Owner's legitimate interests shall be retained as long as needed to fulfill such purposes.
   Users may find specific information regarding the legitimate interests pursued by the Owner within the relevant sections of this document or by contacting the Owner.

The Owner may be allowed to retain Personal Data for a longer period whenever the User has given consent to such processing, as long as such consent is not withdrawn. Furthermore, the Owner may be obliged to retain Personal Data for a longer period whenever required to do so for the performance of a legal obligation or upon order of an authority.

Once the retention period expires, Personal Data shall be deleted. Therefore, the right of access, the right to erasure, the right to rectification and the right to data portability cannot be enforced after expiration of the retention period.

# The purposes of processing

The Data concerning the User is collected to allow the Owner to provide its Service, comply with its legal obligations, respond to enforcement requests, protect its rights and interests (or those of its Users or third parties), detect any malicious or fraudulent activity, as well as the following: Analytics, Tag Management, Interaction with external social networks and platforms, Interaction with live chat platforms, Interaction with support and feedback platforms, Managing support and contact requests, Traffic optimization and distribution, Handling payments, Platform services and hosting, Remarketing and behavioral targeting, Managing contacts and sending messages, Contacting the User, Hosting and backend infrastructure, SPAM protection, Advertising, Handling productivity related activity, Commercial affiliation, User database management, Device permissions for Personal Data access, Registration and authentication, Displaying content from external platforms and Managing data collection and online surveys.

# **Device permissions for Personal Data access**

Depending on the User's specific device, Almina Edutech - Almina Online Kids Academy may request certain permissions that allow it to access the User's device Data as described below. By default, these permissions must be granted by the User before the respective information can be accessed. Once the permission has been given, it can be revoked by the User at any time. In order to revoke these permissions, Users may refer to the device settings or contact the Owner for support at the

contact details provided in the present document.

The exact procedure for controlling app permissions may be dependent on the User's device and software.

Please note that the revoking of such permissions might impact the proper functioning of Almina Online Kids Academy Language Learning Platform.

If User grants any of the permissions listed below, the respective Personal Data may be processed (i.e accessed to, modified or removed) by Almina Edutech - Almina Online Kids Academy.

## **Approximate location permission (non-continuous)**

Used for accessing the User's approximate device location. Almina Edutech - Almina Online Kids Academy may collect, use, and share User location Data in order to provide location-based services. The geographic location of the User is determined in a manner that isn't continuous. This means that it is impossible for Almina Edutech - Almina Online Kids Academy to derive the approximate position of the User on a continuous basis.

## Microphone permission

# The Service is directed to children under the age of 13

- Have their Personal Data deleted or otherwise removed. Users
  have the right, under certain circumstances, to obtain the erasure of
  their Data from the Owner.
- Receive their Data and have it transferred to another controller. Users have the right to receive their Data in a structured, commonly used and machine readable format and, if technically feasible, to have it transmitted to another controller without any hindrance. We will respond to your request within 45 days of its receipt. Should we need more time, we will explain to you the reasons why, and how much more time we need. In this regard, please note that we may take up to 90 days to fulfill your request.

Our disclosure(s) will cover the preceding 12 month period.

Should we deny your request, we will explain you the reasons behind our denial.

We do not charge a fee to process or respond to your verifiable request unless such request is manifestly unfounded or excessive. In such cases, we may charge a reasonable fee, or refuse to act on the request. In either case, we will communicate our choices and explain the reasons behind it.

In cases where we are not processing your personal information, we will indicate to you the physical or legal person to whom you should address your requests, if we are in the position to do so.

In the event that you file an **access** or personal information **processing confirmation** request, please make sure that you specify whether you'd like your personal information to be delivered in electronic or printed form.

#### User

## **Data Subject**

## **Data Processor (or Data Supervisor)**

## **Data Controller (or Owner)**

The natural or legal person, public authority, agency or other body which, alone or jointly with others, determines the purposes and means of the processing of Personal Data, including the security measures concerning the operation and use of Almina Online Kids Academy Language Learning Platform. The Data Controller, unless otherwise specified, is the Owner of Almina Edutech - Almina Online Kids Academy.

#### **Service**

### Cookie
